Cancellations: All cancellations must be received in writing. From time of booking to before April 1st all deposits are non-refundable. There is no refund if cancelled on or after April 1, 2017. Race entry fees are non-refundable once purchased. Any final payments received after April 1st will be charged a \$50 late payment fee.

Not included in price: All items not specifically listed under tour features.

Insurance: Trip cancellation, baggage, health and accident insurance is available on request and is highly recommended to all participants.

Responsibility: These tours are operated by Marathon Tours, Inc. of Chelsea, MA who acts only as an agent for the passenger to the companies offering such services and assumes no liability for injury, damage, loss, accident, delay or irregularity caused by any reason whatsoever by any party offering such services. The right is reserved to cancel the tour prior to departure with a full refund made as full settlement to the passenger. Marathon Tours, Inc. may make any changes or alterations in the itinerary as it deems necessary for the proper handling of the tour and may refuse any person as a member of the tour.
