Cancellations made after January 1st and before May 1st are subject to a \$300.00 per person cancellation fee. All cancellations received on or after May 1st are non-refundable. Race entry fees are non-refundable once purchased. Any final payments received after May 1st will be charged a \$50 late payment fee. Airline tickets are non-refundable once ticketed.

Not included in price: All items not specifically listed under tour features. Transfers from the airport to the hotel. A completed entry form must be completed and returned to Marathon Tours & Travel by every runner with the \$170.00 entry fee.
