Cancellations: All cancellations must be in writing. The deposit of \$400 per marathon runner is non-refundable. The \$200 non-runner deposit is refundable if canceled before February 2, 2018. No refund applies to cancellations received on or after February 2.

Not included in price: All items not specifically listed under tour features. Race entry fees are additional and non-refundable. ***Entry to the Boston Marathon is NOT included with the B2B entry.** Runners need to qualify for the Boston Marathon (see B.A.A. Boston Marathon entry rules).
