GENERAL CONDITIONS

Rates: All prices are based on current exchange rates and may change due to currency fluctuations. Pricing is listed per person. Airfares are constantly changing and we can quote you by phone the lowest rates and most convenient flights for these packages.

Reservations and Payments: A completed tour application together with a deposit of \$400.00 per person must be received before confirming your reservations. Final payment must be received before June 15, 2018.

Cancellations: All cancellations must be received in writing. A refund less a \$200.00 per person cancellation fee will be charged from time of booking to before March 1, 2017. A \$400.00 per person cancellation fee will be charged from March 1st to before June 15th. Cancellations made in writing on or after June 15, 2018 are non-refundable. Race entry fees are non-refundable once purchased. Any final payments received after June 15th will be charged a \$50 late payment fee. Airline tickets are non-refundable once ticketed.

Not included in price: All items not specifically listed under tour features. Transfers from the train station to the hotel. A completed entry form must be completed and returned to Marathon Tours & Travel by every runner with the \$190.00 entry fee. A doctor's note must also be sent stating you are healthy enough to run a marathon. This is required by French law.

Insurance: Trip cancellation, baggage, health and accident insurance is available on request and is highly recommended to all participants.

Responsibility: These tours are operated by Marathon Tours, Inc. of Chelsea, MA who acts only as an agent for the passenger to the companies offering such services and assumes no liability for injury, damage, loss, accident, delay or irregularity caused by any reason whatsoever by any party offering such services.
