Rates: Air and land prices may change due to changes in any taxes or fuel increases.

Reservations and Payments: Each traveler must complete this tour application for the Antarctica Marathon waitlist; however, two people can be on one form. A deposit of \$300 per person must be included with this application in order to secure a spot on the waitlist.

Cancellations: A full refund of initial deposit of \$300 deposit will be refunded if the cancellation is received in writing before you are officially confirmed onto a trip and have accepted the spot.

Deferments: If you cannot attend the trip you have been confirmed on, but do not want to cancel, we can defer your spot once to a future year. If you cannot make the second trip you have been confirmed on, you will forfeit your deposit and you must submit a new one.

Insurance: Medical evacuation insurance is mandatory for all passengers who eventually partake in this trip. Trip cancellation, baggage, health and accident insurance is highly recommended for all participants. All passengers are responsible for any expenses incurred due to airline or ship delays.
